# Strengthening women's safety and security

The majority of gender-based crimes go unreported in Cambodia, owing to low awareness of domestic violence and anti-discrimination laws. Our partner Banteay Srei provides women experiencing violence with access to emergency accommodation, counselling and legal referrals. They're also combatting gender-based violence at the community level through human rights workshops and training. United Sisterhood Alliance provides support to sex workers who have experienced violence.

# **Economic empowerment**

United Sisterhood Alliance raises the voices of some of the most exploited, silenced women in Cambodia: garment workers, sex workers and the rural poor. IWDA works with these women to amplify the call for fair pay and conditions, giving more women and girls the chance to realise their right to a sustainable income and economic empowerment.

# **Systemic Change**

As part of the <u>Women's Action for Voice and Empowerment (WAVE)</u>, <u>Amara</u>, <u>Banteay Srei</u> and <u>United Sisterhood Alliance</u> provide a Cambodian voice to this regional program. WAVE aims to build demand and capability of women to take their place in governance and decision making. It is a truly transformational movement of women across Asia Pacific.

## **ABOUT BANTEAY SREI**

Banteay Srei is one of the leading women's rights organisations in Cambodia. The women of Banteay Srei support community based prevention and intervention of gender-based violence and promote the inclusion of women with disabilities. They also work to include men's participation in addressing issues affecting women. Banteay Srei's goal is to enable women to exercise their political, economic and psychosocial rights to equitable and sustainable development within the family, community and society.

### **POSITION SUMMARY**

The interpreter (Khmer/English) will provide interpretation services for the Gender Team Leader from our partner organisation in Cambodia, Banteay Srei, who is visiting Melbourne from 27-31 August 2018 on a Study Tour. The Gender Team Leader manages the safe house project, which provides a safe place for women and children escaping domestic violence in Siem Reap, Cambodia. She will be meeting with local service providers that support women and children survivors of violence, so that she can develop improved service delivery models for Banteay Srei. She is especially interested in holistic service delivery which offers assistance in a variety of areas including housing, counselling, financial, and legal aid.
